Cllr. B. Jones spoke on behalf of a resident of Ffordd Mynydd Du. His home is situated in the lowest point of the stream. Grids are blocked by debris and the natural way of the water is pushed through the properties garden.

The water flows down the mountain from both sides, there is no attention to the gullies on Mynydd Du the overflow of water is destroying the roads, the haunches on the roads are very deep.

Min-y-Ffordd has also flooded.

The Chair advised to take photographs of the area and send them to Flintshire C.C.

The small toddler area was inspected and the following put forward.

- An extra spring rocker
- A new table top in the play house

It was also discussed painted outdoor numbers and the alphabet on part of the footpath that runs through the middle of the playing field.

Mr Roberts to put costings together for the council's consideration.

Coed-Talon – In attendance: Clerk C.J Thomas

Overall, the site has excellent facilities.

It was noted some of the play equipment and safer surfacing needs urgent jet washing.

Terrig Hill – Due to a landslide traffic lights have been put in place.

## **11. CORRESPONDENCE**

1. A letter of thanks received from the Head Teacher of Ysgol Parc-y-Llan with reference to the grant given by Treuddyn C.C for the breakfast club.

2. A letter received from the Headteacher of Ysgol Terrig with reference to the lack of communication about articles for Treuddyn News.

In the last edition Ysgol Terrig was not approached, the Headteacher was very disappointed.

The editor has ensured members that an email will be sent to the Headteacher giving enough notice for articles to be put together.

Cllr. A. Marshall attended a One Voice Wales online training course: Understanding the Law – Module 4 and became aware that an individual Councillor is not allowed to commit the Community Council to expenditure.

Having a single Councillor responsible for the editing and printing costs can be considered beyond the Council's powers.

Cllr. A. Marshall will send an email to include 'Treuddyn Newsletter' on the January Agenda for discussion.

A Notice of Motion will be sent to all Councillors prior to the January meeting.

## **12. STREET LIGHTING**

No faults reported.

The Clerk – C.J Thoms and Cllr. A. Marshall gave a report from the Teams meeting held with FCC Street Lighting department on 28/11/24

- Installation of the two new steel columns to replace the two concrete columns on Ffordd Top-y-Rhos are to be pushed through as urgent.  
(Christmas Festoons for the above are being ordered by Mega Electrical)
- TCC Energy supply for street lighting – Mr J. Bennett is going to invite Mr D. Jones FCC Street Lighting Manager to a Teams meeting to discuss TCC going under the umbrella of FCC.
- A5104 Street Light opposite Britannia Terrace. The height of the light needs to be increased to give more widespread coverage. The LED could also be changed to a 21 Watt to increase the lux levels which would increase illumination.
- To replace the porcelain fuse holders and broken wooden enclosures with new plastic boxes. One box would approximately cost £150 – Scottish Power would move the supply over for free.
