### 7. PRECEPT REQUIRMENTS 2023-2024

*Review of Treuddyn C.C Finances, to discuss expenditure and projects and to confirm the budget for the new financial year.* 

Members received a copy of TCC finances to date for discussion prior to setting the budget.

Approximate expenditure was discussed working from the expenditure sheet and taking into account the approximate balance of £32,000 carried over to the new financial year.

Projects

Treuddyn Play Area - Small Wheel Play £20,000 plus £10,000 (FCC Matchfunding) and a further £10,000 FCC Matchfunding = £40,000.00 Treuddyn Play Area - CCTV Cameras = £10,000 Treuddyn Play Area - upgrade of Fitness equipment £10,000 (FCC to Matchfund £10,000)

#### **Proposed Small Wheel Play**

Treuddyn C.C has been working with Mr Richard Roberts Play Design Officer – Aura & Leisure Services. Mr Roberts had been in contact with a company specializing in concrete parks, unfortunately during the Pandemic no progress was made. Design options were provided by the company and TCC consulted with the local schools for their choice of design preferred.

The company provided a quote on the 11 January 2023 for the design and build at a cost of £48,500.00 plus VAT. Figures were discussed: Members approved the £8500.00 from the budget on top of the £40,000.00.

The 20% VAT of £9700 would be reclaimed back from HMRC by TCC.

The Chair asked for a vote that the Company, Project and Cost is accepted and approved.

Members agreed - carried unanimously

The Clerk to confirm with the company acceptance of the quote.
