1. Ffordd-y-Rhos. Pavement raised by tree roots in front of the pensioners bungalows.

Cllr. A. Marshall attended a site visit to see what could be done. FCC are going to dig down to see if anything can be taken out and level, this will have to be done with care as not to weaken the trees as they could fall.
