- 3. Cllr. C. Hughes raised the following: "The top road passing the cemetery has no footpath to the chapel it is a very busy road being a main link to the centre of the village. There are a lot of people walking this stretch of road and I would like to see a footpath".

Action: It was agreed to arrange a site meeting with FCC Highway Department to discuss further.

- 4. Cutting back wildlife corridor Clerk is to meet contractors on site to discuss and provide a cost to present to TCC.
- 5. Corner Garage, Treuddyn. Residents concern of vehicles parked on A5104 blocking visibility from the Junction of Ffordd-v-Llan. To report to PCSO's.
- 6. Cllr. A. Marshall gave the following update:
- "The Welsh Government's introduction of the 20mph campaign (30mph down to 20mph in certain areas) this has caused many issues. The 20mph will be coming into force in September. Workshops have been held in County Hall where would be exempt.

The whole of Treuddyn would be included – from the Junction of the Gilrhos to the cemetery this stretch would stay

30mph.
