Minutes of the Meeting held Tuesday 21st November, 2023 at Hafan Deg Community Centre, Treuddyn for 7.00pm

1. APOLOGIES: Cllrs. J. Smith & D. Roberts

2. DECLARATION OF INTEREST

None declared.

3. TREUDDYN COMMUNITY ASSOCIATION

The Chair welcomed two representatives from the committee of the Village Hall.

Treuddyn C.C extended the invitation to discuss the proposal of CCTV on the playing field and the possibility of using space in the hall to house the CCTV equipment.

The representatives mentioned that the committee members were very disappointed that TCC did not respond to their request to support Prosperous Communities Flintshire - Key Fund.

The Clerk stated that Cllr. Eva Bech verbally mentioned a request for support but had no details, it was requested if a letter could be sent with the details of the project which could be shared with members.

The letter was sent to an incorrect email address but was eventually received – the letter was to be discussed at this evenings meeting but told the deadline date had passed.

The following questions and concerns were put to TCC:

Trustees of the village hall feel the housing of the CCTV and any cameras fixed on the outside would make the hall vulnerable to vandalism and theft.

- 1. Who would foot the bill for any damage and if the Insurance goes up?.
- 2. If somebody gets their hands on the CCTV how long is the data held or would it be wiped off immediately.
- 3. Does the playing field justify having CCTV, although we are not completely opposed to it.
- 4. Has the community been asked some may not wish their children to be recorded on CCTV and data held. TCC needs to make sure everything is in place regarding the General Data Protection Regulation (GDPR).

We feel the voice of a few is not enough it's for all the community to agree.

5. Who would have access to the footage and where does the data go?.

AM asked "If this was the list that was going to be sent on the 7th August 2023 which was not received"

It was noted since the CCTV camera has been in place on the playing there has been no incidents reported. Three incidents have happened in which one was very serious.

It was put to members what would people think of all the cameras on the field.

The purpose is catching perpetrators before it has happened.

The TCA committee may consider the following:

- a) The equipment is contained in a cabinet outside the village hall, solar panels would generate the electricity.
- b) A pole on the grounds of the village hall to possibly put a camera.

It was requested for TCA to email the questions they have asked this evening and any other concerns to the Clerk.

The Chair and members thanked the representatives for their time to attend this evening

Action:

- a) It was agreed TCC hold a site meeting on the playing field for further discussion of CCTV.
- b) To hold a public consultation Treuddyn C.C is here to represent and protect the people of Treuddyn.
- c) To invite the security company to a TCC meeting to discuss options of installation.

The Clerk stated that we have a rectangle planter in storage which could be used and to re-order a planter for Coed-Talon.

It was agreed for the planter to be changed.

7. TREUDDYN C.C POLICES – Community Grants

To review and amend the draft policy as discussed in the October meeting.

The final draft policy of 'Community Grants' was presented to members.

It was discussed in the October meeting and agreed number 3 of the guidance notes to add in 'FCC for Youth and other Community Services'

It was proposed by Cllr. R. Cracknell to approve the policy seconded by Cllr. C. Hughes

8. TREUDDYN C.C WEBSITE

To discuss updating of website.

It was proposed to move from the current provider to Wix, the old system dates back to 2009 and Wix is so much

It will still be Treuddyn Community Council website but is open for the community.

Cllr. M. Thornton stated that the site will translate to welsh but is literacy welsh not dialogue welsh.

It was agreed to see how the structure works and welsh translation can be re-visited.

The old website will still run along side the new website until it is live. The website would only be accessible to TCC members to add information.

If anyone has local / old pictures of the area please forward to Cllr. M. Thornton.

The cost of the site is similar to what TCC pay now which is £240 per annum for hosting.

TCC Christmas light competition – judging will take place on Wednesday 20th December 2023 The newsletter will also go onto TCC website.

10. DEFIBRILLATORS

To discuss further sites.

It was noted that a resident who lives in Rhydtalog has kindly given permission for a defibrillator to be put on an outside wall of their property which would be accessible to the public.

This would need to be explored further by TCC as it is on private property and how it would affect the residents insurance and if TCC insurance would cover any potential incidents.

Coed-Talon could be linked with Pontybodkin – The defibrillator could either be placed on the Railway PH or Liverpool House with permission.

Mynydd Du – The area is very remote and would be difficult to find a suitable location.

Ffordd-y-Felin – Members were unsure where a defibrillator could be sited.

The Clerk will look into the cost of defibrillators.

It was also noted that signage giving the location of a defibrillator would be very helpful – a defibrillator can be found in Hafan Deg community centre and on the wall on the entrance to the primary schools.

12. PLAY AREAS

Queen Street play area and Coed-Talon.

There were no matters to report.

A site meeting was held at Queen Street Street Play area on the 18th October for 10am to discuss 'Keep Fit' apparatus.

Attending: Cllr. J. Smith, Clerk (Carolyn Thomas) Mr Richard Roberts Aura and representatives from Proludic designers of play and sport areas.

The keep fit apparatus needs to be 25 metres away from the play equipment, the ideal area would be on the green on the left hand side as you come into the play area from the gate near the village hall.

Different designs were looked at. Proludic will submit a design and costing for TCC to consider.

Small Wheel Play – A planning application is to be submitted from TCC.

The Clerk to contact Bendcrete who will be installing the concrete wheel play if a start date could be confirmed for 2024.
