Minutes of the Meeting held Tuesday 21st February, 2023 at Hafan Deg Community Centre Treuddyn for 7.00pm

5. MR MARK CHARLESWORTH – WREXHAM RIDING CLUB

Mr Charlesworth has been invited to the meeting to provide background to the Youth Cycling Club and to discuss the use of TCC BMX Track and the possibility of future working arrangements.

The chair welcomed Mr Charlesworth to the meeting and invited him to speak.

MC “ Fibrax are the club’s main sponsors. Wrexham Riding Club is one of the main established clubs in Wrexham, the youth side ‘Go Ride’ has been running for 7 to 8 years. All coaches are DBS checked for coaching, the club is Third Party Insured to use other venues and also carries Public Liability Insurance. Any money made by the club goes back to the children, children that take part in racing events the club waiver the entry fee.

Biking gets children out in the fresh air and the opportunity to enjoy themselves. The Club have used facilities at Rossett, Alyn Waters, Queensway, Marsh Tracks, Rhyl and Bro Alyn. Treuddyn facilities have been used during the last three years.

There are twenty to thirty active children in the club, all having different abilities. If the club is given permission to use the track, children would be allowed to join on the day, a consent form would be given to the child for parent/guardian consent. A number of children from Treuddyn village had taken the opportunity to join in when previous events were being held.

Mr Charlesworth apologised for the issue that occurred last September at the BMX track – It was a lack of preparation on their side and was not their intention to exclude children, the club would ensure the local children are made aware when cycling coaching is happening.

We would like to have three coaches available to coach 8 to 10 children in a group.

If the club is allowed to use the track again we would engage with the village schools and set up a face book page for the children to know when sessions will be held”.

CH “TCC did not know anything about the events that have been held at the track, and were disappointed that nobody had been in touch”

CS “ It would be beneficial if a Satelite Club could be considered for Treuddyn”.

MC “ Coaches are all volunteers – it would be good to encourage the children to use the different tracks. In the longer term we hope to have bikes available for the children to use. Safety checks are carried out on the bikes and all children participating must wear a helmet and appropriate clothing.

The Club will try and work better with TCC and is hoping that permission is given to use the track 4/5 times a year. The age group is from 4 to 12 years of age; the very young would use the flat surface inside the Muga. The purpose of a ‘Pump Track’ you use body movement to get around”.

RC “ TCC will be adding a ‘Small Wheel Play’ next to the BMX track which would be ideal for the younger children”.

MC “We are looking for somewhere for the third weekend in March 2023. Coaching sessions last one hour and we also hold mini race days, which run for approximately 1 to 1½ hours – 4 to 5 times a year.

I would like to thank TCC for the invitation this evening and the opportunity to explain who we are ”.

The Chair and members thanked Mr Mark Charlesworth for attending.

The Chair asked members for their comments on the information given.

Members felt there had been a misunderstanding and the person whom they had been in contact with had not given the club TCC contact details.

It was put forward that coaching events are posted onto the Treuddyn Community face book site and once a year feedback to TCC what level of engagement they have had from local children.

It is a good opportunity for children to take up the coaching sessions.

It was proposed to allow four sessions for the year.

The chair asked for a vote for four sessions – all in favour.

It was also noted that Mr Charlesworth is a volunteer and to thank him for his time.
