4. MEMBERS ALLOWANCE 2023/2024 TOWN & COMMUNITY COUNCILS

The allowance was discussed in October 2023 in which members were unsure if they should take the allowance of £150 in part or full.

Community / Town councillors are entitled to receive a payment of £150 per year towards the costs and expenses of serving your community.

It was discussed again this evening in which Cllr. B. Jones proposed that members take the full allowance of £150.

The Clerk reminded members if they do not wish to take the allowance it must be put in writing to the clerk.

5. CCTV – QUEEN STREET PLAYING FIELD

Cllr. A Marshall is still working very hard on gathering information and costs for the proposed Installation of CCTV – the following update was given.

Mega Electrical have given a quote to provide the following:

- 2 poles plus 2 ducts, 2 CCTV cameras and a small cabinet they have based based their quote that power would come from the village hall. Cost of £8500 (cost of the cameras approximately £5000).
 - Some Town and Community Councils have their own CCTV cameras the Police go to these to recover any footage.
 - Cllr. A. Marshall has done a basic disclosure check – DBS
 - Has contacted North Wales Police – No member of the Community Council or the public would have access to view the cameras this would be done by the Police or another person with authorisation to do so.
 - Has contacted FCC who gave the following cost information.
 1. One CCTV camera would cost approximately £3280.00
 2. Cost for Installation £190
 3. Unlimited data plan £600 per year.
 - FCC would charge a fee to look at footage.

A question asked: Who would the camera and data belong to? Cllr. A. Marshall would be speaking with Zena Jones ECC Surveyor & CCTV manager to ask further questions.

- The Home Office provides a ‘Surveillance Camera Code of Practise’
- For another party to take over the responsibility of the CCTV cameras and data would mean TCC moving away from the Code of Practise.

6. TCC STREET LIGHTING

Working party inspection of lights held on the 04/02/2024 – Cllrs. A. Marshall, M. Thornton & the Clerk Carolyn Thomas.

The information collected on the inspection:

- Steel or concrete Pole
- LED light or 35 SOX light
- Condition of light and fuse box

Cllr. A. Marshall has updated 70% of the TCC Street Lighting spreadsheet. A meeting will be held with FCC Street Lighting Department to discuss how energy can be saved. Energy could be saved during the night deciding which lights are left on or off.

8. PARKING ON FFORDD Y LLAN

During school drop off and pick up.

The issue of cars parking on pavements and close to Junctions is an ongoing matter that some drivers seem to think this is the right thing to do not taking into consideration the safety of other car users, pedestrians and especially children walking or cycling to school.

TCC has visited this issue on a number of occasions and tried to resolve some of the parking issues on Ffordd y Llan. Meetings with an Officer from FCC some years back did not come to anything. It is not a simple fix as vehicles need to park somewhere.

Cllr. B. Jones has strong feelings for the safety of the children and stated motor cars seem to be more important. He would like to see parents going through the proper process of handing their child over to the teacher to take into the class room – is there a hand over?

BJ: “We see cars on pavements and grass verges”

A member stated a Zebra crossing near the War Memorial would be ideal.

CS: “Parking around the Bull Ring is worse than the school. Parked cars are useful for slowing traffic down”.

The council have received no notification from Mr John Morris North Wales Police Community Speed Watch Manager when to go out with the speed gun.

RC: "If TCC contact the Head Teachers of both schools if there are any concerns with child safety during drop and pick up."

It was noted the 20mph speed in the village is good outside the school campus.
To ask the PCSO's to visit the schools during the drop off and pick up times.

10. PLAY AREAS

Treuddyn and Coed-Talon

Coed-Talon - No issues reported

Treuddyn - BMX Track Maintenance and Refresh – A letter received from Clark & Kent Contractors who built the track.

The company are specialists in track design and build.

The following costs have been provided by the company:

1. A site visit to inspect the track and cost any works required £500
2. To send a team including either Clark or Kent to carry out their typical maintenance package for £1500 + vat, this would include grass cutting, re-seeding of problem areas, cutting in track edges, localised repairs to tarmac surface (if required). An inspection would also be carried out and price for any major surface work to the dust elements of the track.

Members discussed the options above. The clerk informed members there is money ring fenced for the maintenance of the track.

Cllr. A. Marshall proposed TCC opt for the maintenance package. Seconded: Cllr. B. Jones
All in favour – carried.

11. LITTER PICK – Held Sunday 17th March in the village of Treuddyn

To receive a report on the event.

Approximately 30 bags of rubbish was picked. Thank you to all who participated in the Spring litter pick
The preparation and system for the litter pick worked on the day.

The Chair thanked everyone involved in the preparation for the litter pick.

It was noted that it would have been better to engage with the members of the public first (those that turned up for the litter pick) as they looked a little worried when they read the briefing. There was quite a lot of broken glass found in the play area – 2 people contacted Cllr. J. Smith for advice. First Aid was also required – nothing serious.

Members stated the 'Litter Pick' should become an annual event.

Cllr. E. Bech editor for the Treuddyn News will do an article on the Litter Pick.

Cllr. M. Thornton stated he had a brilliant contact from FCC Streetscene – Adriana Szostakowska. Who provided a lot of useful information and also a list of additional funding opportunities.

There is a Community Orchard Grant that could be applied for – It may be something to look at for the 'Wildlife Corridor'

Cllr. M. Thornton and the Clerk will look further into the grant.
