4. REPORTS ON ANY MATTERS ARISING FROM THE MINUTES – 18th February 2025

6. COUNCILLOR'S UPDATE ON THE RADAR SPEED GUN IN THE COMMUNITY

Cllr. J. Smith gave the following update:

“The trained group of people were going out on a regular basis monitoring the speed of the traffic in Treuddyn and Coed-Talon we were doing very well with majority of the motorists being very polite. When the 20mph speed limit came into force the Police stopped ‘Community Speed Watch’ groups from going out because of the hassle the new speed limit was causing. We haven’t been out since this advice was given.

Three people are needed when out with the radar gun: one to pick up the colour and model of the car and two watching speed and noting number plate”.

Cllr. J. Smith to reactivate the group.

7. PLANNING APPLICATIONS

The following application came in a couple of days prior to the meeting therefore was not on the agenda.

Proposal: Demolition of Garage and Erection of a Single Storey Recreational Summer House

Location: 3, Britannia Terrace, Corwen Road, Treuddyn, Mold, CH7 4LH

Members gave Cllr. C. Metcalf the opportunity to speak about the application but was not permitted to put forward any observations for TCC's consideration.

Members studied the application, and the following comments will be submitted to the delegated planning officer.

- a) The garage has been knocked down and the concrete base put in.
- b) Studying the plans the proposed Summer House looks far to big. Summer houses normally have one large room, this has four rooms. It looks more like a small residential dwelling than a recreational summer house.
- c) There are no planning notices up near the property.

8. PLAY AREAS Treuddyn & Coed-Talon

Coed-Talon. A temporary fence running along side the bridleway was put up by FCC Streetscene to stop escaped cattle entering the play area, the cattle had been on the playing field.

The Clerk has spoken to FCC Countryside Ranger regarding the temporary fence who is going to speak to Mr Ian Williams FCC Streetscene when a permanent fence is going to be put up.

9. MONTHLY ACTION PLAN

Matters raised with FCC Streetscene. Discussed and updated.

Pot holes are still an ongoing concern in all areas.

1. Potholes on Ffordd y Ferlin and Queen Street have been reported by Cllr. R. Cracknell and Cllr. A.

Marshall via the FCC app.

2. Ffordd y Rhos. Tree roots have lifted the pavement in front of the pensioners bungalows.

The trees have been inspected by Mr D. Ellis FCC Tree Inspector who has confirmed the trees belong to FCC Housing.

The Clerk to contact the Housing Department highlighting this concern.

10. CORRESPONDENCE

To acknowledge and note correspondence received.

1. Letter received from the Wrexham Cycling Club asking permission to use the pump track at Treuddyn playing field on the 14th June 2025 for coaching. The usual notices will be put up advertising the event to give the opportunity for the local children to take part.

Resolved:

It was agreed to give permission for the Cycling Club to use the pump track on the stated date.

2. A letter of thanks received on behalf of the pilots, medical team and staff at Wales Air Ambulance for the donation of £100 from TCC.

3. A letter from Eisteddfod Gaderiol Treuddyn thanking TCC for the continued support and the donation received of £250.00. It is greatly appreciated.

11. STREET LIGHTING

The Street Light outside 7 Ffordd y Rhos has been repaired twice in three weeks.

The Clerk to check the invoice when it comes in that TCC only pay for one repair.

The Clerk and Cllr. A. Marshall attended a meeting on the 19th February 2025 to discuss the supply of energy for TCC Street Lights with Mr Darell Jones FCC Street Light Manager.

Treuddyn C.C will be terminating the contract with Scottish Power, from the 1st April 2025 Treuddyn C.C will be under the umbrella of Flintshire C.C Streetlighting Department for the new energy supplies.

Treuddyn C.C should be saving approximately £200 per month around £2,200 per annum.

Proposed Installation of Defibrillator at Rhydtalog.

The location and cost were also discussed. The best location would be next to the notice board; the defibrillator would be mounted on a board attached to a metal post with an electric feed coming from a nearby street light.

The cost for installation is approximately £1900 plus the cost to purchase the defibrillator, £2000 has been put into the 2025/26 budget. The cost for the installation will be discussed in the setting of the 2026/27 budget for this project to move forward.

Cllr. A. Marshall has also been in contact with FCC Housing who are responsible for the running of Hafan Deg Community Centre with reference to moving the defibrillator, explaining the length of time of getting to the defibrillator from inside the building. The defibrillator would be easier to access if moved to an outside wall with the electric supply being inside the building. Talks are ongoing and the question being asked if Housing could fund.
