

## **CYNGOR CYMUNED – TREUDDYN COMMUNITY COUNCIL**

### **Minutes of the Meeting held Tuesday 19<sup>th</sup> July, 2022 at Hafan Deg Community Centre Treuddyn for 7.00pm**

4. **PUBLIC SESSION** 6.50pm to 7.00pm

The Chair welcomed Mr Ian Williams FCC Streetscene to the meeting.

*Mr Ian Williams gave the following updates:*

Drainage on Mynydd Du–Black Mountain. Two extra gullies are to be installed by the bridge, the area cleared and tidied up – this is almost completed.

An additional gulley will be put in near Plas-y-Mhowys. Also near Ty’r Felin, Ffordd y Felin the drainage system to be re-routed and upgraded.

Ditching is being cleared along Ffordd y Rhos.

On the A5104 from the corner garage towards the Junction of Ffordd y Gilrhos, gullies are being replaced.

Ffordd-y-Rhos – parts to be surface dressed and re-patching works.

The siting of the new dog bin on Ffordd y Rhos – the location is fine.

The silt that is cleared out of ditches and left at the sides, members asked could this be taken away. Mr Williams explained that it is very expensive to get rid of and would need to be taken to a specialist site – waste can’t be put on FCC sites.

Members stated the waste would look better levelled out once it has dried.

*Members asked Mr Williams to inspect the following:*

1. To look at the culvert on Ffordd-y-Gilrhos
2. Infill two big potholes on Ffordd-yr-Odyn
3. Inspect along Queen Street near Erw Ffynnon.

The Chair and members thanked Mr Ian Williams for attending this evening.

Replacement of gate on the old railway line – Pontybodkin / Coed-Talon end.

An email received from Mr Alistair Hemphill in relation to the price to replace the access onto the old railway line, the cost will be £568.70. This is to replace everything except the kissing gate rails and post which are ok.

Llanfynydd C.C have agreed to meet half the cost.

It was proposed by Cllr. J. Smith to pay £284.35

### **1. FCC Match Funding Scheme – Improvements to Children's Play Areas 2022/23**

Aura is writing to advise TCC that due to the rollover of the £20,000 funding (making it a £40,000 scheme) for the small wheel play project, there appears to be little merit in TCC expressing an interest in matchfunding for 2022/23

Members felt the project has been on hold since lockdown and delays are costing more. Mr Richard Roberts Aura Play Design Officer is dealing with the tendering process to put a contractor in place for the build, which is taking time.

Members agreed to express an interest and put forward £10,000 for Match Funding improvements to the play areas as there are items that need upgrading such as the keep fit apparatus.

2. Treuddyn Youth Club newsletter.

Volunteers were hoping to attend the Community Council meeting this evening but are unable to do so. Members received a copy of the report.

3. Eisteddfod Gadeiriol Committee. A letter of thanks for the grant of £500. TCC will also be kept informed as to planning permission etc. from FCC regarding the plinth.
